Bosnia and Herzegovina – specific national context

Complex administrative stucture:


- State level,
- two entities (Federation of BiH and Republika Srpska),
- 10 cantons in FBiH,
- Brcko District BiH

General Elections :

- BiH Presidency
- State and entities' parliaments
- Cantonal assemblies

Local Elections:

Complex electoral system with asymmetric solutions:	18 changes and amendments to the BiH Law since 2001 % of invalid ballots: 2002 (5,86%); 2004 (6,34%); 2006 (6.90%); 2008 (6.00%); 2010 (6,87%); 2012 (6,05%); 2014 (7,64%) Low turnout (54.47%)	
Huge number of political subjects and candidates	2014 General Elections: 3.282.581. voters; 65 political parties; 24 independent candidates and 24 coalitions; in total 753 candidates list with 7.748 candidates	
Approx. 3.3 million of voters and different voters' categories	Regular voters; voters who vote in person or in absentia (displaced persons), out of country voters (temporary absent and refugees- vote by mail or in BiH Embassies); Voters registered to vote by mobile team;	
Insufficient application of modern electoral solutions	Slow counting process due to the open list system	
Election administration	The BiH CEC – main electoral management body; consists of 7 members with 7 year mandate; at municipal level there are 143 MECs (mandate 7 years); Polling station committees (PSCS) are formed ad hoc, nominated by political subjects for each elections; appointed by MECs; approx. 52.000 members of PSCs.











- •Additional education of voters.




PSCs Sanctioning Proceedings Initiated in 2015

Policy/Practice Implications

- No formal ERM system exists within the BiH CEC.
- The possibility of using ERMTool by all MECs in BiH is currently being examined. This includes considerations for establishment of a connection via the appropriate digital media (tablets, SMS, or online) with the BiH CEC to enable the mapping and transfer of local level data in a real time. This should facilitate adequate and timely action to be taken by the BiH CEC in order to eliminate situations which could pose potential risk for the electoral process.
- Train at least one staff member in each BiH CEC's department and MECs on how to use the ERMTool.
- Introduction of the practices to use the ERMTool for analysis of the entire election process and report to the BiH CEC.
- The findings of the report could be used for initiating the election related legislation and introduction of better management practices to avoid risks in all segments of the elections.
